### **RELATIONSHIPS AND SERVICES**

What investment services and advice can you provide me?

We offer personalized portfolio management services to retail investors by giving you continuous advice and making investments for your account based on your individual investment goals. As a standard part of our portfolio management services, we monitor the investments in your portfolio on a quarterly basis. We will contact you (by phone or e-mail) at least annually to discuss your portfolio and to see if there are any changes in your financial circumstances and investment guidelines. You can choose a portfolio management account that allows us to buy and sell investments without asking you in advance (a "discretionary account") or we may give you advice and let you make the ultimate decision regarding the purchase or sale of investments (a "non-discretionary account"). In order for you to establish a portfolio management relationship with us, we require a minimum account size of \$1,000,000 although we may waive this requirement under certain circumstances. There are no account minimums for our financial planning and consulting services. A written agreement must be entered into which specifies the services we will provide and the specific fees we will charge before we can begin to deliver any services.

What fees will I pay?

We charge an asset-based fee for our investment management services quarterly in arrears. In regard to our asset-based fee, the more assets that are in your account, the more you will pay in fees and therefore, we may have an incentive to encourage you to increase the assets in your account.

In addition to our advisory fees, you may be responsible for paying some or all of the following types of fees:

- Fees paid to the custodian that holds the assets in your account
- The fees paid to managers of the mutual fund(s), ETFs, separate accounts and alternative investments that are selected for your account
- Transaction fees when an investment is bought or sold for your account

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investment over time. Please make sure you understand what fees and costs you are paying.

The firm's financial professionals are compensated on a fixed monthly salary basis plus applicable employee benefits. No one in the firm is paid any incentive compensation, commission and/or payment based on the firms' revenue or profitability. Further, no financial professional's compensation is based on the number of new accounts obtained, number of accounts serviced or in any way directing client assets to any one or a group of investment or financial products. This structure disincentivizes conflict of interest between service and compensation.
